

# Code of Conduct – Kernen

## 1. Kernen in general

1.1 Kernen is a social space designed for residents of Kirkebjerg and its surrounding areas to gather as a community, with well-being, learning opportunities, and fitness offered through various activities and events. A significant aim for Kernen is to foster vitality, safety, and, generally, a pleasant everyday life. Kernen's primary purpose is to create an inclusive space for everyone, whether through social interaction or more solitary contemplation on one's own, with respect for Kernen's other users.

#### 2. Behavior

- 2.1 All use of Kernen requires mutual respect and space for all activities and participants, implying that each user of Kernen should conduct themselves in a manner respectful of Kernen's other users and activities.
- 2.1.1 Any user should avoid bothersome or unnecessarily noisy behavior at all times and restrain from acting in any manner that could be harmful or hurtful to others. In all areas of Kernen, including outdoor activities, the expectation is respectful consideration of the other users and the furniture and tools made available for use in Kernen. Music from your amplifiers/phone is not permitted in Kernen's areas or via Kernen's amplifiers without prior agreement with the staff.
- 2.1.2 Kernen offers several different activities and spaces for such. Generally, individual activities should occur in the specific room, area, or time indicated for that activity. Food and beverage may only be consumed in Spiseriet or other marked areas. However, it is allowed to consume drinks and snacks provided by Spiseriet. Used cutlery and glassware must always be brought back to Spiseriet. Food and beverage brought from home may be consumed on the roof of Kernen, inside Orangeriet and in marked areas inside Kernen. Beer and wine are available for purchase in Spiseriet. Beer and wine may be consumed in Orangeriet in connection with the rental of Orangeriet.
- 2.1.3 Periodically, external arrangers will host events in Kernen. Please note there may be alternative sets of rules for participation regarding specific events.
- 2.1.4 Every user is responsible for their guests and should ensure that guests comply with Kernen's Code of Conduct.
- 2.1.5 All users are obligated to clean up after use of an area in Kernen. For example, this involves returning borrowed cutlery and silverware and disposing of any remaining garbage as displayed. At no time may debris and waste be left behind, neither within public areas nor next to the garbage cans/containers in place for this purpose.



- 2.1.6 Used tools and furniture should be returned to their original place after use and be cleaned if needed or as required by display.
- 2.1.7 Smoking is not permitted both indoors and outdoors in Kernen. Likewise, the use of drugs is strictly prohibited. Beer and wine are available for purchase in Spiseriet and may only be consumed there. Beer and wine may be consumed in Orangeriet in association with social events.

## 3. Instructions regarding the use of Kernen

- 3.1 There may, at times, be a need to follow special instructions concerning Kernen's use. For example, outbursts of a pandemic may necessitate a unique set of additional precautions. In such a case, all required instructions will be on display in Kernen. Without exception, users must abide by any extra precautions or instructions when they occur. - 3.1.1 Correspondingly, all users should follow the instructions provided by the working personnel at Kernen.

## 4. Kernen's Wi-Fi

4.1 Users have an opportunity for free Wi-Fi while visiting Kernen. Every single search of prohibited and/or illegal material or exposure of pornography or pictures of violence is considered to be in violation of the Code of Conduct in Kernen.

#### 5. Responsibility

- 5.1 Users of Kernen and the facilities of Kernen including the outdoor facilities on the roof terrace are acting at their own risk. Children's use of Kernen and the facilities of Kernen should be supervised by a responsible adult or guardian.
- 5.2 Failure to follow Kernen's Code of Conduct may prompt oral or written notices to which any user is required to comply, including dismissal or revoked access to use Kernen in the future, repeal of leasing contract (as per Lejelovens § 171), or repeal of tenancy (as per Lejelovens § 182).
- 5.3 Employed staff in Kernen or on-duty security have the right to reject and dismiss users if these pose threats, behave violently, or use intolerable language. If needed, staff and security will summon the police to ensure the safety of the people and restore public law and order.
- 5.4 Failing to follow the Code of Conduct can, in all cases, cause the public authorities to be involved.
- 5.5 Kernen and its facilities are monitored by security cameras in compliance with Danish law.
